## **Occupant Protection Enforcement Campaign**

*Willowbrook Police Department is cracking down on seatbelt violations*

**Willowbrook, IL** – The *Willowbrook Police Department* will have additional officers on patrol between October 17<sup>th</sup>, 2020 and November 2<sup>nd</sup>, 2020 looking for drivers and passengers who are not buckled up. This enforcement includes drivers who do not properly secure children in an appropriate child safety seat. The enforcement effort is part of the national “Click it or Ticket” campaign focusing on seat belt use. Please see the following statistics as reported by the Illinois Department of Transportation:

### **Why is Click It or Ticket such a focus if 94.6 percent of people buckle up in Illinois?**

- Of the 1090 traffic fatalities involving occupants with recorded seat belt and restraint usage to date in Illinois in 2017, 54 percent were unbelted or not restrained properly in the vehicle.

### **How do seat belts protect people in crashes?**

- The webbing spreads forces over the strongest parts of the body;
- The retractor engages (locks) and slows you down to keep you from hitting other occupants or interior vehicle parts;
- They work in conjunction with the air bags and vehicle crumple zone to best protect you from the violent forces of a crash.

The Willowbrook Police Department hopes that the enforcement action taken this Halloween season will increase the chances that everyone will make it to their destinations safely.

Funding for Click it or Ticket enforcement efforts are provided by a grant from the Illinois Department of Transportation, through the National Highway Traffic Safety Administration.



On Tuesday, September 22nd, 2020 at approximately 8:30am, Officer Volek was called to the Red Roof Inn about a possible recovered stolen auto. Upon arrival, Officer Volek was advised by the victim, that his dealership loaner vehicle was taken from his residence in Burr Ridge sometime during the night and was located via GPS at the Red Roof Inn. During that same time, Officers Biggs and Chavez-Jimenez were dispatched to multiple Burglary from Motor Vehicle reports by residents in the surrounding area. Officers were able to determine that a cell phone stolen in one of the burglaries was showing the current location at the Red Roof Inn and obtain doorbell camera footage of the possible offenders. Upon viewing the camera footage of the offender, Officer Chavez-Jimenez recalled seeing a subject matching the description in the area. Officers searched the area and located the suspect and his female companion. Both suspects attempted to flee the area upon being confronted, but were ultimately caught and arrested by Officers Volek, Biggs, and Chavez-Jimenez.

Detective Robles assisted with the initial and follow up investigation. Both suspects were tied to a room at the Red Roof Inn, where numerous burglary proceeds were located. The suspect were also tied to a fraudulent credit card purchase at the Willowbrook Target. During interviews and follow up investigations, the two suspects were tied to numerous motor vehicle burglaries and 4 stolen automobiles in Willowbrook, Burr Ridge, Darien, Addison, and DuPage County. Due to the thorough investigation done by all involved, a timeline was established tying both suspects to multiple felonies. Both offenders were charged accordingly with additional charges pending.

All the officers involved should be recognized for his hard work and attention to detail. Their diligence in seeing this case through until the end, led to multiple criminals being taken off the streets of Willowbrook.
