SUBJECT: Sgt. David Gaddis's Retroactive Pension/Widow's Pension Benefit

As you may recall, Sgt. David Gaddis retired on July 13, 2019 and passed away on October 23, 2019. His initial annual pension amount was \$83,182.28 and the monthly pension was \$6,931.86, which was based on the salary at the time as the new union contract beginning May 1, 2019 had not been approved.

The new contract covering May 1, 2019 – April 30, 2022 was approved by the Village Board on January 11, 2021. As noted in the attached schedule, the amount of retroactive pension pay due to Sgt. Gaddis's estate is \$707.39, and the amount due to his widow, Victoria Gaddis, is \$2,963.40. Mrs. Gaddis's new monthly fixed pension going forward will be \$7,129.42.

ACTION: Approved the retroactive pension benefit for Sgt. David Gaddis's estate of \$707.39 for July - October 2019; the retroactive widow's benefit to Mrs. Victoria Gaddis of \$2,963.40 for November 2019 – January 2021; and the new benefit for Mrs. Victoria Gaddis beginning February 1, 2021 of \$7,129.42.
